Memberships are for one year with renewals due on the anniversary date of membership. The Society sends a renewal notice to members in the month when their renewal is due. The Society is a nonprofit 501(c)(3) organization. Membership dues and other contributions to the Society are tax deductible.

In the fall of 2010 the Board voted to raise the Family dues rate to \$30, and the Single dues rate to \$20, beginning January 1, 2011.

In addition, in 2005 the Board created a new category of Honorary Member to be awarded at its discretion to people who have contributed professional services to the Society. ## MEETINGS:

Membership Meetings are held quarterly. Nominal dates for the quarterly meetings are the third Sunday in February, May, August, and November at 2:00 PM. The dates can be rescheduled if necessary to accommodate specific programs. The February Membership Meeting is also the Society's Annual Meeting.

Presentations at the 2010 membership meetings included:

- February —Dr. Carole Nash, a Middle Atlantic archeologist who specializes in Native American studies and human ecology in mountain settings, spoke about the Madison Archaeology Project (MAP) and the Native American Communities of the Blue Ridge Foothills.
- May —Katrina Powell, a Madison County native, spoke about the research for her two books: *Anguish of Displacement* and *Answer at Once: Letters of Mountain Families in Shenandoah National Park, 1934-1938*. . **These books speak to the condemnation of land belonging to mountain families in the Blue Ridge in order to establish the Shenandoah National Park and the anguish suffered by these families as a result of this process.**
- August — Marc Wheat, President of the Memorial Foundation of the Germanna Colonies, **and a descendent of the first colony settlers**, discussed the early days of first and second colony settlers and expressed a desire to meet every Madisonian descendent of these families.
- November —Mrs. Karen Beck-Herzog, Management Assistant and Public Affairs Officer of the Shenandoah National Park presented “Celebrating Shendoah Connections: Past, Present, and Future”, a discussion **of all these periods in conjunction with the 2011 celebration of the Park's 75th Anniversary**

Detailed summaries of the above meetings can be found in the Society’s newsletters, which are published in February, May, August, and November.

## COUNTY LIAISON

The Society continues to work with the Madison County Board of Supervisors in areas of mutual interest. The Board of Supervisors was kept informed of the progress of the restoration work on the Slave Quarters dependency of the Kemper Residence. We look forward to our continued partnership with the Board of Supervisors for the maintenance of the Kemper Residence and outbuildings, the Arcade Museum, and other historical properties.

## KEMPER RESIDENCE

The Residence and two outbuildings, the Law Office and Slave Quarters, are leased by the Society from the County. The Residence is used for a variety of meetings, tours, open houses, and other special occasions.

At the 2010 Taste of the Mountains festival visitors to the residence were greeted by General and Mrs. Kemper (as impersonated by Daniel & Evelyn Desantis).

The Residence is available for rent to private parties of the community. Rentals in 2010 were handled by Mary Haught. The “Kemper Girls” continue to be responsible for the decorating and cleaning of the residence. Present members of this group are Mary Haught, Pam Krause, Maryvonne Longley, Kay Reiss, Heidi Sage, and Jill Schreiner.

## **KEMPER RESIDENCE OUTBUILDINGS**

The Law Office and Slave Quarters are outbuildings located in the yard behind the Residence. Restoration of the Law Office began in 1999 and was completed in 2003. By the beginning of 2010 restoration of both buildings was complete except for the construction of a chimney on the Slave Quarters, for which further funding was required. A cost estimate of \$6900 for the chimney construction was obtained in early 2010.

In April, 2010, the local chapter of the Questers, an international group which raises funds for historic preservation, presented the Society with a check for \$6500, which they raised through a combination of local fund-raising events and a grant from their National Headquarters. Another \$590 was raised at the Antiques Appraisal jointly sponsored by the Questers and the Society on June 26, 2010. The Society then contracted with Joe Wayner to oversee the chimney construction. Period bricks were purchased and Brent Ryder and his cousin, Charles Ryder began construction in late December, 2010. The Society is most appreciative of the Questers for funding this project.

## **ARCADE MUSEUM**

The Society operates the Arcade Museum, a small historic two-story brick building located in the heart of downtown Madison. The Museum is open Tuesdays, Thursdays and Fridays from 10:00a.m. until 2:00p.m. Travelers from all across the United States visit the Museum looking for their Madison roots. The Museum was visited by school groups, the Germanna Foundation Tour, and others throughout the year.

Exhibits at the museum are under the direction of Curator Beppy White. Both the upper and lower floors house permanent and changing exhibits depicting the history of, and life in, Madison County. Permanent exhibits include the Rapidan Railroad exhibit, furnished by Everette Weakley, the Claude Yowell collection of Native American prehistoric tools, the Strode collection of Native American artifacts from Madison County and photographs taken in 1935 of the men, women and children who were living in our mountains when the Shenandoah National Park was established.

Changing exhibits in 2010 included old Madison-made chairs, a collection of blacksmithing tools and hand forged items used by farmers and home owners and a collection of old kitchen utensils, all from the extensive collection of Steve Hoffman. Changing exhibits planned or being considered for 2011 include Madison Drug Co. history and E. A. Clore Furniture Co. history.

On the upper floor there is a Research room, which contains a collection of genealogies and obituaries of Madison families, histories and pictures of old Madison County churches, schools, homes and other buildings. A workroom on the second floor is used for constructing archival storage containers, preparing exhibits and storing exhibit materials and supplies.

The Arcade is staffed by a volunteer group under the direction of Beppy White. Volunteers come one or more days a month to staff the museum. The life of the museum is strong due to our many faithful workers. New volunteers are always welcome. ## **BENEFIT TEAS**

The Society held two benefit teas in 2010, on March 24<sup>th</sup> and September 29<sup>th</sup>. Each guest was served the "Kemper House" tea, which was complemented with a selection of sweets, savorys, and fruits. Gross proceeds were \$684 from the March tea and \$884 from the September tea. The teas have proven to be very popular in the community and will continue to be a primary source of funds for the Society.

## **CEMETERY DATABASE PROJECT**

The cemetery committee members finally have something to show for all of the work that has been done over the past 30 years in surveying and documenting burials in Madison County. Many thanks to Mary Wright for putting all of our data onto our computer and then generating CD's, which are now for sale by the Society.

Documentation was begun back in the early 80's by Earl Estes then passed on to Sandy Stowe. Many volunteers have helped over the years and work is continuing. This is a project that will never be finished.

We now have a CD for sale at the Arcade Museum containing the burials documented so far in Madison County. There are over 5000 listings. We have spent most of our time lately trying to find the small family graveyards before they disappear. This is an ongoing project and we need help in updating the church cemeteries. A few of the local churches have not been surveyed at all and if they could give us a list of burials it would be a big help. There will always be a few mistakes in our work so if you buy a CD and find errors or omissions we would like to know so that we can make corrections (and you will get a free updated copy). The price of the CD is \$10.00.

## **MADISON COUNTY PICTORIAL HISTORY**

In the spring of 2010 the Society contracted with nationally known Arcadia Publishing Company to publish a pictorial history of Madison County as a part of its popular *Images of America* series. Society Board member Doris Lackey and society member Trish Crowe, agreed to be co-authors. Archivist and board member Beppy White helped with fact checking and writing. Mary Wright entered pictures and text into the database, with computer consultation from Charles Moncrief. Charles and Mary were awarded honorary memberships for their pro-bono professional contributions. Archeologist Carole Nash and Architectural Historian and Board member Ann Miller served as project consultants.

Many people from Madison County and beyond contributed more than 650 images of people and places in Madison County. The stories and photographs tell a rich history of Madison County. These were scanned and are now preserved in the database. Contributors are acknowledged in the introduction of the book with much gratitude. The book publisher limited photographs for the book to no more than 240 images and no more than 18,000 words. The Society anticipates our own publication of photographs that are not in the book. Arcadia Publishing has set the publication date of book **Images of America, Madison County** for the week of March 21, 2011. The Society will have 400 of the books in hand by that time and will sell them at the Arcade and at the Kemper House Tea on March 30. They will also be available at Barnes and Noble and Amazon, among others, as well as from local vendors who choose to feature it. The cost for the book will be \$23.00 including tax.

## **2010 GERMANNA COLONY REUNION**

For over fifty years the descendents of the 1717 Germanna Colony have been gathering in late July for a reunion. These have become three-day events with one day spent in Madison County. In 2010 Seventy-two guests came from California, Oregon, Washington state, Arizona, Nebraska, Ohio, Kentucky, Tennessee, Missouri, Illinois, Indiana, Georgia, Pennsylvania, Virginia and neighboring states, as well as Canada. Thrift Road was the focus of a bus tour since so many of the descendents in attendance were families of Broyles, Waylands, Weavers, Yeagers and other family names that are still in the county. Lunch was served by the ladies at Hebron Church with ten other Madisonians as greeters to match visiting families with local families. This was followed by the history and tour of the Hebron Church. The day ended at the Prince Michel Winery where the two bus loads of guests could purchase wine with their family name on it

## **ACQUISITIONS**

The Society continues to receive gifts that enrich our collection. Genealogies, both published and hand-written, have helped fill out our Family Files. ## **PLANNED ACTIVITIES**

Activities planned for 2011 include the following:

- Hold Board Meetings on the second Thursday of each month.
- Hold Membership Meetings in February, May, August, and November. These are tentatively scheduled for the third Sunday of the respective months, but the dates may be changed if necessary to accommodate program participants.
- Hold the Annual Meeting coincident with the February membership meeting.
- Continue publication of the Quarterly Newsletter in February, May, August, and November.
- Hold fund-raising teas in March and September
- Continue to store appropriately all holdings in an acid free environment at the Arcade or at the Kemper Residence.
- Continue building the database of archival materials.
- Continue to collect family genealogies for the Research Room at the Arcade.
- Continue collecting Madison Cemetery data and issuing updated versions of the database on CD.
- Continue operation of the Arcade as a museum with exhibits featuring Madison County History.
- Changing exhibits planned or being considered include the histories of the two oldest businesses in Madison still in business: Madison Drug Co. and E. A. Clore Sons, Inc.
- Continue sales of maps, books, calendars, ornaments, Cemetery data and other items of significance to Madison County history.
