



THE HORSE IN THE AMERICAN CIVIL WAR

On Sunday May 20, 2012, James Flanagan, President and Founder of the Fauquier Civil War Round Table will speak at the quarterly meeting of the Madison County Historical Society. Mr. Flanagan's presentation is entitled "The Horse in the American Civil War." It is a power point presentation about the importance of the horse in the war: they moved guns, pontoon bridges, food and equipment, ambulances, and carried Cavalry troops and officers. More than one and

a half million equines (mules and horses) were killed in the American Civil War - three animals for every soldier that died. In the battle of Gettysburg alone about 1500 died.

Mr. Flanagan's presentation is a continuance of our recognition of the American Civil War Sesquicentennial celebration. In February 2011, Thomas Matthes spoke to the Society about James Madison's republican legacy for the Constitution. In May of 2011, Jayne Blair spoke to the Society about the Sesquicentennial of the Civil War and why it is important, a war that is the most studied and researched fought in the last 500 years. It saw this young Nation grow up, a nation only 75 years old when the war began and still struggling with the role of a strong Federal government in their lives and the role it played in their lives versus that of the States.

There were a number of cavalry engagements here in Madison County, the most important of which was the Battle of Jacks Shop. The 150th anniversary of that battle will be recognized next year. The Civil War was fought in great part in Virginia and affected the lives of local residents immensely. Mr. Flanagan's presentation of the importance of the horse in the war shows another fascinating aspect of this enormously complex part of our history.

Mr. Flanagan has a B.S, M.S., M.St. in Biology and Geology from Frederick College and Randolph Macon, respectively, and has done extensive graduate work. He is an adjunct professor of Biology at Lord Fairfax Community College and is a Narrator and speaker on The Battle of Kelly's Ford and Brandy Station as well as this presentation on the role of The Horse in the Civil War.

The meeting will be held in the County Administrative Offices auditorium at 2pm Sunday May 20th. Everyone is invited to attend and refreshments will be provided in the Kemper Residence next door following the presentation.

MOUNTAIN MEMORIES PRESENTATION

Our speaker at the February 19, 2012 quarterly meeting of The Madison County Historical Society was Mr. Jim Lillard, Commander, Kemper-Fry-Strother Camp Number 19, Sons of Confederate Veterans. The subject of his presentation was "Mountain Memories" and was designed specifically for the Madison Historical Society. Mr. Lillard talked about the families who lived in our local mountains before they became a portion of the Shenandoah National Park, and included in the presentation original family photos as well as photos from the Library of Congress. In a very poignant and often humorous power point presentation he showed pictures of the mountain farms, and spoke to the quality of life experienced by these mountain folk and how they made their living. The subject matter of the presentation was of particular interest because it relates a story of local history which involved the relatives of many present day Madisonians and was well attended.

This year we are showing off lots of items given to us by Madisonians over the years. In the 1980's we were given a still which has been in a closet until now. It is not set up correctly because some of the parts are missing. The speakers stand made by a Madison native and used by President Hoover when he spoke at the Madison Day celebration is upstairs. We also have some wool blankets made at the Madison Woolen Mill and a beautiful 'second day' wedding dress.

On the main floor there is a display of lots of old toys made of tin or wood. No plastic back then. Another case has a number of old shoes for women, men and children. There is even a pair of homemade socks. Other interesting items are a pearl and shell decorated "hair receiver", a "mustache curler" and new pictures on the walls. The permanent exhibits are Arthur Rothstein pictures in the "Before the Park" display, Mr. Strode's Indian artifacts, Everette Weakley's train display and the Imlay's War Between the States display.

In our gift shop we have a brand new book for young people by Ann Ferguson titled "A Brand New Home for Young James Madison" for \$15.95.

THE JUNIOR ADVISORY COUNCIL

Christian Hansen gave a presentation to the board of directors of the Madison County Historical Society at their board meeting on March 12th. Christian, who is Chairman of the Council, described the structure and purpose of this Council. This junior council is associated with the Museum of Culpeper History and is primarily composed of high school students of the Culpeper schools. The group does projects for the museum through the guidance of Lee Langston-Harrison of the museum staff. The members of the council are students that want to help their community, are imaginative, motivated, and interested in history. Christian thought that there would be interest at the Madison County school system in forming a similar group there that might be interested in working with the Madison County Historical Society. It is nice to see groups such as this formed in the school systems and working with the community and such activities certainly should be encouraged.

BATTLE AT JACK'S SHOP

September 22, 2013, marks the anniversary of the Battle of Jack's Shop. The Historical Society is joining with the Madison County Conservation Fund Committee, the Piedmont Environmental Council, Madison County Public Schools and others in jointly preparing for a variety of events to celebrate that battle. Clearly one of the most significant battles during the Civil War fought in Madison County, it was one of the largest cavalry battles during the entire war.

While the joint committee is planning a series of speakers, workshops and school year projects in advance, the activities will culminate in a daylong "muster/campground" on September 21, 2013 at the Madison High School. (The anniversary actually falls on Sunday, September 22.) Events that day will include a Civil War campground reenactment providing a "living history", bus tours of the battlegrounds, student demonstrations and projects. Maps, books and self-guided tour info will be available.

In the weeks leading up to the actual anniversary a lecture series is planned for the high school auditorium. Speakers will include local historians Harold Woodward, Frank Walker and Jim Lillard. The school system is planning to include topics related to the period in its' curriculum for the coming school year.

The Historical Society's representative on the joint planning committee is Linwood Imlay.


ACQUISITIONS
